bearing date on or about the Twenty eighth day of September in the year
One thousand eight hundred and thirty eight under the hand and seal of
Luis Vernet then late of the Falkland Islands and then resident of the
City of Buenos Arpes in South America After reciting that his private
Property existing on the Falkland Island had been taken possession of by Her
Britanic Majesty's Government He the said Luis Vernet did make ordain
constitute and appoint and in his place and stead did put and depu'te the
said James Bromilow to be his true and lawful Attorney for him and in
his name and to his use and benefit to petition ask demand sue for
recover and receive of and from Her Britanic Majesty's Government and
from all and every Person and Persons whomsoever All and every debt and
debts claim and claims Sum and Sums of Money and every other estate
and effects whatsoever due and owing to him or thereafter to become due
owing or payable to him in any manner or way whatsoever and to make
composition for the same or any part thereof and if occasion should be or
require for him and in his name or otherwise to sue take and pursue all
lawful or requisite ways and means for recovery of said claim or claims
debt or debts Sum or Sums of money or composition of any claim or
claims debt or debts Sum or Sums then due or thereafter to become due
as aforesaid and upon payment or recovery of all or any one or more
of the said claim or claims debt or debts Sum or Sums of money or
other estate and effects due or which should become due as aforesaid for or
in respect of the matters aforesaid for him and in his name or otherwise
receipts acquittances or other sufficient releases and discharges to make
sign and execute for the same and generally for him and in his name
to do perform and execute all other lawful and reasonable acts deeds matters
and things whatsoever as fully and absolutely in every respect as he himself
might or could do if personally present and actually did the same And
he did thereby authorise and empower his said Attorney from time to time
to constitute and appoint one or more Person or Persons to act under him
as his substitute or substitutes for executing and effectuating all and every
the powers and purposes aforesaid as he should think proper and the same
again at his pleasure to revoke and other or others in his or their place
or places to substitute And he did thereby ratify and confirm all and
whatsoever his said Attorney and his substitute or substitutes should in
his name or otherwise lawfully do or cause to be done in or about the
premises by virtue of these presents Now know ye that in consideration
of the premises the said James Bromilow in pursuance and execution of

the power or authority in this behalf contained in the hereinbefore recited
letter of Attorney both by these presents make constitute and appoint John
Galt Smith of Liverpool aforesaid Merchant his Executors or Administrators
to be the true and lawful Substitute and Substitutes of the said James
Bromilow for him and in his name or in the name of the said Lewis
Vermet his Executors or Administrators to execute and exercise all and every
or any of the powers and Authorities expressed and contained in the hereinbefore
recited Deed Poll or letter of Attorney in as full ample and effectual manner
to all intents and purposes as he the said James Bromilow could have
executed and exercised the same if those presents had not been made and
generally to do and execute all such acts matters and things as may be
required in the Premises and to appoint from time to time a substitute
or substitutes for all or any of the purposes aforesaid the said James
Bromilow so far as he lawfully can hereby ratify and confirming and
agreeing to ratify and confirm whatsoever the said John Galt Smith his
Executors or Administrators or his Substitute or Substitutes shall lawfully
do or cause to be done in or about the Premises In witness whereof
the said James Bromilow hath herunto subscribed his name and
affixed his seal this Third day of August in the year of our
Lord One thousand eight hundred and thirty nine
